Declaration of immovable property acquired or held in India under the general permission granted vide Reserve Bank's Notification No.FERA.133/93-RB dated 26th April 1993

Instructions :

1. *The declaration should be completed in duplicate and submitted directly to the Chief General Manager, Exchange Control Department (Foreign Investment Division-III), Reserve Bank of India, Central Office, Mumbai - 400 001 within 90 days from the date of acquisition of the immovable property.*
2. *A separate form should be used for each immovable property.*
